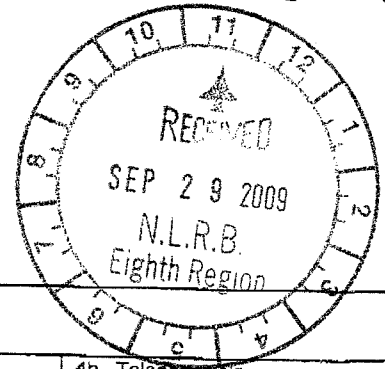

The Employer eliminated the quarterly dinners because the workforce voted to be union; the Employer eliminated the quarterly dinners without negotiating with the Union; on or about August 21, the Employer changed the hours of the quality assurance person without negotiating with the Union; on an ongoing basis and particularly from the time he began sitting in on negotiations, the Employer has been over supervising Jerome Ivery because of his union activity; the Employer changed the way workers were kept informed about their 401(k) contributions without negotiating with the Union.
